SUMMARY STATEMENT: The Mat-Su Trail and Park Foundation awarded a \$100,000 grant to the Borough for development of the Settlers Bay Coastal Park.

The grant funds will be used to help develop the initial infrastructure necessary to open the park to the public. Development will be in accordance with the recreation development plan, adopted by Assembly Ordinance Serial No. 18-050, August 19, 2018.

The grant requires the Borough to provide a match of \$100,000. The Great Land Trust collaborated with the Borough in the application and committed to providing \$50,000 as cash match. Previous

legislation relied on the remaining match to be provided as inkind donations of labor and equipment.

The FY20 projected budget shortages have given rise to the need to hedge future availability of staff and equipment with a commitment of the remaining \$50,000 in required grant match from the FY19 Areawide Community Transportation Block Grant match.

The resolution will amend the budget to reflect the change in the source for the required grant match.

RECOMMENDATION OF ADMINISTRATION: Staff respectfully requests the Assembly re-appropriate \$50,000 from Project 99999, FY19 Areawide Community Transportation Grant Match, Fund 480, to the Settlers Bay Coastal Park, Project No. 15040, Fund 440 (MSB007387), and approve the amended budget.
