**MATANUSKA-SUSITNA BOROUGH
ORDINANCE SERIAL NO.19-069**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY REAPPROPRIATING \$50,000 FROM PROJECT NO. 99999 GRANT MATCH, FUND 480, TO THE SETTLERS BAY COASTAL PARK PROJECT NO. 15040, FUND 440, TO DEVELOP THE PARK (MSB007387).

WHEREAS, the Borough received property from the Great Land Trust identified as the Settlers Bay Coastal Park, which abuts the Knik Arm in the Settlers Bay and Secluded Point subdivisions; and

WHEREAS, the Assembly adopted Ordinance Serial No. 18-050, adopting the Settlers Bay Coastal Park Recreation Development Plan, June 19, 2018; and

WHEREAS, the Community Development Department has partnered with Great Land Trust on a Mat-Su Trail and Park Foundation grant application for development of the park; and

WHEREAS, the Mat-Su Trail and Park Foundation approved the application and awarded Grant No. 2018-402 in the amount of \$100,000 to the Borough; and

WHEREAS, the Assembly adopted Ordinance Serial No. 18-106 December 18, 2018 that accepted \$100,000 in grant funds from the Trails and Parks Foundation; and

WHEREAS, the grant requires a match of \$100,000, which will be provided by a \$50,000 cash contribution from the Great Land Trust and a \$50,000 cash from the Borough; and

WHEREAS, the Great Land Trust will provide a cash match of \$50,000 through direct purchase of goods and services for the project; and

WHEREAS, the Borough will provide \$50,000 cash match from the fiscal year 2019 Areawide capital appropriation for the Community Transportation Block Grant match, which was not awarded to the Borough; and

WHEREAS, the Manager authorized a request to seek Assembly reappropriation of the grant match funding.

BE IT ENACTED:

Section 1. Classification. This Ordinance is a noncode ordinance.


Section 2. Re-appropriation. The Assembly hereby reappropriates \$50,000 from project no. 99999, Community Transportation Block Grant match, fund 480, to the Settlers Bay Coastal Park, project no. 15040, fund 440 (MSB007387).

Section 3. Effective Date. This ordinance shall take effect upon adoption.
