SUMMARY STATEMENT:

This legislation is coming forward to change the joint meeting dates with the School Board and the Planning Commission.

Currently in March the Assembly has a joint meeting with the School Board the $2^{\rm nd}$ Tuesday and the Planning Commission the $4^{\rm th}$ Tuesday. The School District has been requesting their joint meeting be moved to a different date due to spring break, which we have continually done for a couple of years now. The requested code change would change the School Board meeting to the $4^{\rm th}$ Tuesday and the Planning Commission to the $2^{\rm nd}$ Tuesday.

This would also change the October joint meeting with the Planning Commission to the 2^{nd} Tuesday rather than the 4^{th} Tuesday.

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY AMENDING MSB 2.12.075, TO CHANGE THE DATES THE ASSEMBLY HAS JOINT MEETINGS WITH THE SCHOOL BOARD AND THE PLANNING COMMISSION.

BE IT ENACTED:

Section 1. <u>Classification</u>. This ordinance is of a general and permanent nature and shall become a part of the Borough Code.

Section 2. <u>Amendment of section</u>. MSB 2.12.075 is hereby amended to read as follows:

(A) The assembly and school board shall meet jointly on the second Tuesday in September and December and the fourth Tuesday in March [OF THE FOLLOWING MONTHS] for the purposes indicated and for other purposes as they deem appropriate. However, a meeting may be changed to a different day or may be canceled by the mayor and the chairman of the school board. However, a meeting day may be changed and the assembly and school board may otherwise meet as they see fit:

(B) The assembly and planning commission shall meet jointly on the second [FOURTH] Tuesday of March and October for purposes as they deem appropriate. However, a meeting may be changed to a different day or may be canceled by the mayor and the chairman of the planning commission. The assembly and planning commission may otherwise meet as they see fit.

Section 3. <u>Effective date</u>. This ordinance shall take effect upon adoption.
