SUMMARY STATEMENT: On May 16, 2019 (written decision May 24, 2019), the Platting Board approved the vacation of the 50-foot wide Section Line Easements, contingent on Assembly approval. The vacation request was submitted by the State of Alaska Department of Natural Resources in conjunction with a subdivision plat on the far eastern side of the borough. The vacation was requested to un-encumber proposed lots potential building sites and provide for better, more efficient use of the property. Alternate public access routes consist of the constructed 100-foot wide Millennium Loop and Sunup Drive and the unconstructed 100-foot wide Better Way Lane right-of-ways, a 100-foot wide Public Access Easement at the south end of Millennium Loop, and the remaining unconstructed 50-foot wide section line easements. Additional 20-foot wide public utility easements will be granted along the dedicated roads the subdivision and 50-foot wide public access easements will be granted along the shores of the two unnamed lakes within the subdivision. The proposed alternate access is adequately wide to satisfy all present and reasonable foreseeable uses. Continued access to adjacent lands is ensured by the remaining unconstructed Section Line Easements and the right-of-ways and Public Access Easements shown on the plat.


RECOMMENDATION OF ADMINISTRATION: Staff recommends the Assembly approve the vacation as the Platting Board's decision to vacate is consistent with MSB 43.15.035(B)(1)(a) and (B)(2)(b) and 43.15.040(B)(8) as equal or better access to all areas affected by the vacation and to the unnamed lakes is provided and a preliminary finding of approval was obtained from the State of Alaska, Department of Natural Resources. Vacation is pursuant to AS 19.30.410, 11 AAC 51.065, and to MSB 43.15.035 and MSB 43.15.040.



CONDITIONS of APPROVAL:

The Platting Board approved the revision of the preliminary plat and vacation of a portion of the section line easements within Sections 1 & 12 for One Thousand Skies Sunrise, contingent upon the following:

- 1. Comply with original conditions of approval dated June 27, 2018.
- 2. Pay Postage and Advertising fee.
- 3. Obtain the Borough Assembly approval of the vacation within 30 days of Platting Board's written Notification of Action. MSB Assembly has 30 days from the date of the Platting Board decision to deny the vacation.
- 4. Obtain DNR Final Decision of Approval for the Section Line Easement Vacation.
- 5. Submit final subdivision and section line easement vacation plat, signed by the State and those with a legal and beneficial interest in full compliance with Title 43.
- 6. Provide updated Certificate to Plat executed within 7 days prior to recording and provide beneficiary affidavits from holders of legal and equitable interest, if any.

FINDINGS of FACTS:

- 1. The preliminary plat modification is pursuant to MSB 43.15.16(H)(6), *Preliminary Plat Submittal and Approval*.
- 2. The redesigned plat reflects adjusted rights-of-way to accommodate the constructed road and to adjusted lot lines due to the adjusted rights-of-way and constructed cul-de-sac.
- 3. The section line easement vacation is pursuant to AS 29.40.120 through AS 29.40.140, MSB 43.15.035 *Vacations* and MSB 43.15.040, *Section Line and State Recognized RS-2477 Easement Vacations*.
- 4. The vacation is consistent with MSB 43.15.035(B)(1)(a) & 43.15.035(B)(2)(b) as the vacation is conditioned upon the final approval of a plat affecting the same land which provides equal or better access to all areas affected by the vacation and alternate or better access to the lake is being provided or exists as shown on the plat.
- 5. SOA DNR has issued a preliminary decision of approval for the vacation of the section line easements (EV-3-269). Assembly approval and DNR final finding of approval is required prior to recording the vacation plat, per A.S. 19.30.410, MSB 43.15.035(D) & 43.15.040(B)(6).
- 6. The petitioner posted notices for the section line easement vacation notifying the public of the date, time, and place of the public hearing.
- 7. The petitioner is dedicating 100-foot wide public access easements at the south end of Millennium Loop for additional alternate access consistent with DNR Preliminary Finding of Approval, MSB 43.15.035(B)(2)(b), and MSB 43.15.040(B)(8).

- 8. The petitioner is reserving on the plat a 50-foot wide public access easement upland of and contiguous with the ordinary high water line of the two unnamed lakes within the proposed lots.
