


SUMMARY STATEMENT: On April 12, 2019, the Matanuska-Susitna Borough Purchasing Division issued a solicitation requesting bids from qualified contractors to provide labor, equipment and materials to perform annual road maintenance for Road Service Area (RSA) #29 Talkeetna.

In response to the advertisement, one bid was received. Award recommendation is being made to D & S Road Services as the lowest responsive and responsible bidder Total Amount Bid. Contract term is for a five year period beginning July 1, 2019 and ending June 30, 2024, subject to annual appropriation of funds by the assembly. In accordance with MSB 3.08.170(B), Administration requests authority to modify the resulting contract completion date by 30 days for unforeseen circumstances.

The Public Works Department, Operations & Maintenance Division will be administering the contract.
