MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 19-067

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$25,000 FROM THE ALASKA STATE DEPARTMENT OF NATURAL RESOURCES, DIVISION OF PARKS AND OUTDOOR RECREATION, OFFICE OF HISTORY AND ARCHAEOLOGY; AND REAPPROPRIATING MATCH FUNDING OF \$16,667, FROM THE AREAWIDE GRANT MATCH ACCOUNT, FUND 480, TO FUND 440, PROJECT NO. 20203, FOR THE HISTORIC PRESERVATION PLAN, PHASE 1 CERTIFIED LOCAL GOVERNMENT GRANT.

WHEREAS, the Alaska State Department of Natural Resources, Division of Parks and Outdoor Recreations, Office of History and Archaeology has awarded a Certified Local Government Grant in the amount of \$25,000 to the Borough; and

WHEREAS, this grant is intended to cover a portion of the funding necessary for updating the 1987 Borough Historic Preservation Plan; and

WHEREAS, since 1987 the Borough has continued to rapidly develop and much additional information about its history has been learned; and

WHEREAS, the Borough can better preserve and interpret its history with an updated historic preservation plan; and

WHEREAS, the state of Alaska requires a 40 percent cash match, equaling \$16,667, for this grant program; and

WHEREAS, in the fiscal year 2018 Capital Projects budget the Assembly appropriated \$200,000 in Areawide fund for Grant Match; and

WHEREAS, it is our intention to use the remaining balance of \$2,044.15 to meet a portion of the required match for this grant; and

WHEREAS, in the fiscal year 2019 Capital Projects budget the Assembly appropriated \$1,170,000 in Areawide fund for Community Transportation Grant Match; and

WHEREAS, the Borough did not receive the Community Transportation grant, but did receive other grants; and

WHEREAS, it is our intention to use \$14,622.85 to meet the remaining portion of the required match for this grant.

BE IT ENACTED:

Section 1. Classification. This Ordinance is a non-code ordinance.

Section 2. Grant Acceptance. The Matanuska-Susitna Borough Assembly does hereby authorize the acceptance of \$25,000 from the Alaska State Department of Natural Resources, Division of Parks and Outdoor Recreation, Office of History and Archaeology and agrees to comply with applicable provisions.

Section 3. Appropriation Source. The Matanuska-Susitna Borough Assembly does hereby appropriate grant funds in the amount Page 2 of 3 Ordinance Serial No. 19-067

of \$25,000 from the Alaska State Department of Natural Resources, Division of Parks and Outdoor Recreation, Office of History and Archaeology and agrees to the fund 440, project no, 20203, for the Historic Preservation Plan Update, Phase I.

Section 4. Reappropriation Source. The Matanuska-Susitna Borough Assembly does hereby reappropriate grant match funds in the amount of \$16,667 from the fiscal year 2019 Community Transportation Grant match, fund 480 to fund 440, project no. 20203, for the Historic Preservation Plan Update, Phase I.

Section 5. <u>Effective Date</u>. This ordinance shall take effect upon adoption.
