WHEREAS, the borough fire services areas have been awarded grant funds from the Alaska State Division of Forestry Volunteer Fire Assistant grant program in the amounts of \$7,498.35 for Butte, \$6,589.72 for Caswell Lakes, \$7,500.00 for Talkeetna, \$3,750.00 for West Lakes, and \$7,272.00 for Willow, for a combined total amount of \$32,610.07; and
