A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE SCOPE OF WORK AND BUDGET FOR THE CONNECTING PATHWAY ALONG FOLSOM DRIVE TO THE BOGARD ROAD EXTENSION EAST PATHWAY, PROJECT NO. 35299.

WHEREAS, the Borough has received a grant in the amount of \$17,113 from the Mat-Su Trails and Parks Foundation; and

WHEREAS, the Assembly accepted and appropriated the grant by Ordinance Serial No. 19-075; and

WHEREAS, the grant requires a Borough cash match in the amount of \$6,919; and

WHEREAS, with the adoption of Ordinance Serial No. 19-075 the Assembly reappropriated \$4,419 of the cash match from the 2015 Legislative Grant Match Senate Bill 119; and

WHEREAS, with the adoption of Ordinance Serial No. 19-043 \$2,500 of the cash match was accepted and appropriated by the Assembly; and

WHEREAS, the grant requires a Borough in-kind match valued at \$1,637; and

WHEREAS, \$1,637.00 of the in-kind match for this project will be provided by the Capital Projects Department, Pre-Design

and Engineering Division salaries, materials, and easement survey; and

WHEREAS, no expenditures can be made until the Assembly has approved a scope of work and budget.

NOW, THEREFORE, BE IT RESOLVED, that the Assembly approves the following scope of work and budget for project no. 35299:

#### **SCOPE OF WORK**

Construction of an 8 foot-wide connecting pathway along Folsom Drive from Equestrian Street to the Bogard Road Extension East pathway. A culvert and level fill will be installed in the Bogard Road Extension East ditch for the connecting pathway to traverse.
