A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY AMENDING THE BUDGETS FOR THE LANDFILL VEHICLE PURCHASE WASTE CONTAINER ROLL OFF TRAILER PUP, PROJECT NO. 25001, FUND 420.

WHEREAS, a landfill vehicle purchase of a waste container roll-off trailer pup project no. 25001, fund 420, requires more funds than originally appropriated in fiscal year 2018 budget; and

WHEREAS, projects for Central Landfill Building Improvements Water Monitoring Well Installations project no. 25020, fund 420, were appropriated in the fiscal year 2018 capital projects budget; and

WHEREAS, the project is being completed with funds remaining in project no. 25020, fund 420; and

WHEREAS, the fiscal year 2019 solid waste capital projects budget included central landfill and transfer sites equipment box truck w/forklift project no. 25048, fund 420, with appropriated funds of \$135,000; and

WHEREAS, the project is being completed with funds remaining in project no. 25048, fund 420; and

WHEREAS, Ordinance Serial No. 19-078 authorized the reappropriation of funds from project no. 25020, fund 420, to project no. 25001, fund 420; and

WHEREAS, Ordinance Serial No. 19-078 authorized the reappropriation of funds from project no. 25048, fund 420, to project no. 25001, fund 420; and

WHEREAS, combining these Solid Waste capital projects will provide the Central Landfill with enough funding to complete project no. 25001, fund 420, through Sourcewell cooperative purchasing program (formerly NJPA) totaling \$77,298.15; and

NOW, THEREFORE, BE IT RESOLVED, that the Assembly approves the amended budgets for project no. 25020, fund 420, Water Monitoring Well Installations; and project no. 25048, fund 420, Box Truck w/Forklift to project no. 25001, fund 420, to allow for the purchase of a waste container roll off trailer pup.
