WHEREAS, Alaska State Department of Fish and Game Board of Fisheries meetings will be held in Anchorage February 7 through February 20, 2020; and

WHEREAS, the cost of advocating for the Borough Fish and Wildlife Commission proposals at this meeting is an integral effort in returning salmon to the Borough; and

WHEREAS, the Borough Fish and Wildlife Commission submitted five proposals to the Board of Fisheries; and

WHEREAS, in previous Board of Fisheries years, the Borough utilized a consultant to assist at the State Board of Fisheries meetings; and

WHEREAS, the Fiscal Year 2020 funding of \$20,000 in the Administration Operating funds is insufficient for a Board of Fisheries cycle year based on the last two cycles (Fiscal Year 2014 and Fiscal Year 2017), which were about \$50,000 each; and

WHEREAS, in 2017 the Borough produced a document It Takes

Fish to Make Fish - Keep the Corridor Open to provide the Alaska

State Board of Fisheries members with information about northern district fisheries for their Upper Cook Inlet Finfish meeting, which was held in Anchorage in February 2017; and

WHEREAS, in addition to being used for the 2017 State Board of Fisheries meeting, the publication was sent to Borough legislators and officials to inform them about Upper Cook Inlet fishery issues; and

WHEREAS, the Borough Fish and Wildlife Commission incurs costs to attend these meetings; and

WHEREAS, the Planning Department has funding in other project accounts to supplement the Fiscal Year 2020 Operating Budget; and

WHEREAS, the at the August 6, 2019 meeting the Assembly, directed the Planning Department to reallocate and amend the scope project funds.

NOW, THEREFORE, BE IT RESOLVED, that the Assembly hereby approves the following amended scope of work and budgets.
