**MATANUSKA-SUSITNA BOROUGH
ORDINANCE SERIAL NO.20-017**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$15,474 FEDERAL FUNDS FROM THE NATIONAL PARK SERVICE PASSED THROUGH ALASKA DEPARTMENT OF NATURAL RESOURCES FOR THE SETTLERS BAY COASTAL PARK CULTURAL RESOURCES SURVEY, PROJECT NO. 15040, FUND 440; REAPPROPRIATE \$9,508 FROM AREAWIDE FUNDS, PROJECT 99999 GRANT MATCH, FUND 480 TO FUND 440, TO SATISFY THE REQUIRED MATCH.

WHEREAS, the Matanuska-Susitna Borough received property known as the Settlers Bay Coastal Park abutting Knik Arm in the Settlers Bay and Secluded Point subdivisions; and

WHEREAS, the Matanuska-Susitna Borough Assembly adopted the Settlers Bay Coastal Park Recreation Development Plan at the regularly scheduled meeting June 19, 2018; and

WHEREAS, wheelchair accessible trails are planned along the bluff above Knik Arm, which is the most culturally rich area in the park; and

WHEREAS, the National Park Service passed federal funds through the Alaska Department of Natural Resources in the amount of \$15,474 for a cultural resources survey in the Settlers Bay Coastal Park as part of the Alaska Historic Preservation Fund Program; and

WHEREAS, the grant requires the Borough to provide a match of \$9,508; and

WHEREAS, the Borough will provide the \$9,508 cash match from the Fiscal Year 2019 Areawide capital appropriation for the Community Transportation Block Grant match, which was not awarded to the Borough; and

WHEREAS, the grant funds will be used to conduct a phase I cultural resources survey to help guide development in the park.

BE IT ENACTED:

Section 1. Classification. This Ordinance is a non-code ordinance.

Section 2. Acceptance. The Assembly hereby accepts \$15,474 from the Alaska Historic Preservation Fund Program for a cultural resource survey to support development of the Settlers Bay Coastal Park.

Section 3. Appropriation Source. There is hereby appropriated by the Assembly \$15,474 from the National Park Service passed through Alaska Department of Natural Resources, to fund 440, project no. 15040 for Settlers Bay Coastal Park Cultural Resource Survey.

Section 4. Re-appropriation. The Assembly hereby re-appropriates \$9,508 from Project 99999, Community

Transportation Block Grant Match, Fund 480, to the Settlers Bay Coastal Park, project no. 15040, fund 440.

Section 5. Effective Date. This ordinance shall take effect upon adoption.
