SUMMARY STATEMENT: On December 18, 2019, the Matanuska-Susitna Borough Purchasing Division issued solicitation 20-079B requesting bids from certified Microsoft resellers to enter into a three (3) year Microsoft Enterprise Agreement.

This new agreement essentially replaces the previous Microsoft Enterprise Agreement that has been in place for the last six years. Entering into a new Enterprise Agreement will continue to keep our overall software costs as low as possible and allow for planned software updates when they are tested and available. Licenses can be acquired and installed immediately. This cuts costs associated with researching and tracking licenses, generating and processing purchase orders, and helps eliminate funding shortfalls and confusion associated with upgrades to Borough core software and operating systems. The Enterprise Agreement will allow the Borough to stay in compliance with Microsoft licensing requirements at a reduced cost when compared with purchasing all components individually.

The investment will be \$197,011.32 for the first year and \$255,141.52 for each of the next two years for a total of \$707,294.36 over the three year period. This three year investment will support our existing licensing and will also provide for Software Assurance which gives the license owner the ability to upgrade to the latest version of any licensed product. This licensing level also includes access to various Microsoft tools that assist in managing computers and provides for elevated Microsoft support.

The contract term will begin July 1, 2020 and end June 30, 2023 and is subject to annual appropriation of funds by the Assembly.

The Information Technology Department will be responsible for contract administration.

In response to the advertisement, two (2) bids were received. The award recommendation is being made to the lowest responsive and responsible bidder.

The Microsoft (MS) Enterprise Agreement (EA) includes volume licensing for multiple MS software products: Windows Server (Active Directory, Exchange, SharePoint, Data Center, Teams, more), Windows 10 (desktop), Office (Word, Excel, Outlook), and Client Access Licenses (CALs). CALs allow individual user to access the many server-based systems we run.

- Note that the number of servers and workstations has increased over the years. Post cyber attack the number of workstations increased due to a number of workstations now being 'off-domain' for security reasons.
- In the first 3 years, we were paying for all licensing. In the second 3 years we were paying 'Software Assurance', version upgrades only.
- In FY21 Microsoft is changing their licensing model to an annual 'Subscription'.

- We have reduced the number of CALs, by first right sizing the number in FY17, and then by giving low-use DES Responders the right type of CAL at a lower cost.
- In FY18 the database, SQL and SharePoint licenses were split from the main EA because we got a better price by splitting.
- In FY20 we added the 'E3', this gives us Multi-Factor Authentication, which is essential for Security, and it lets us full access to Office 365, which is MS Office applications in the cloud, Word, Excel, PowerPoint, Outlook (Exchange), Teams, and SharePoint. This also allowed us to drop other software. This is in keeping with the strategic goal of "Enterprise Approach to Systems". The Office 365 access will allow us to start top migrate top cloud computing, which is a longer term goal.
- The FY21 quote for the EA portion, represents a new vendor at a better price then we were getting from the old vendor.
- The FY22 quote goes up, but at the same time we will eliminate other software, Enterprise Approach. We will gain the premiere anti-Malware protection in the industry. We will also gain <u>full</u> access to O365 services and further prepare us for migration to the cloud. Once cloud migration begins, we can start reducing the need to upgrade all local infrastructure.
- Note that the overall increase from FY15 to FY23 is \$17,000 in 8 years. This also represents access to more Microsoft products, better security, preparation for the cloud, and reduction of other software in our environment, for overall savings.

This legislation seeks to approve only the EA portion of this licensing, the top line for FY21-FY23. We are still working on new quotes for the SQL and SharePoint portion for FY21-23. New legislation will be prepared for that when ready.
