SUMMARY STATEMENT:

The Recreation Services Division of the Community Development Department request that the Assembly re-appropriate \$25,000 from the fiscal year 2020 Community Development Department operating budget, Fund 100.170.124, to Fund 440, Project 10157, for the purchase and installation of video surveillance equipment at the Brett Memorial Ice Arena.

In the fiscal year 2020 area-wide budget appropriations, the Assembly approved \$25,000 for the purchase and installation of video surveillance equipment at the Brett Memorial Ice Arena, as

part of our commitment to protect Borough assets, improve our ability to monitor the facility, and record injuries and accidents.

The installation of the video surveillance equipment was to have been completed earlier this spring. However due to delays as a consequence of the Covid-19 pandemic, the project will not be completed by the end of the fiscal year. Therefore, staff is requesting the available funds, which are available in the fiscal year 2020 Community Development Department operating budget, be re-appropriated into a non-lapsing project fund.
