Chief Hightower,

Thank you for your quick response, we are excited to work with your department on this project. For the demonstration day it is reimbursed, so you will need to provide documentation of hourly rates and timesheets/logs for the amount you are requesting reimbursement for. The maximum amount that can be reimbursed is \$6000, and it only pertains to the demonstration day (both the actual date of the demonstration as well as any work the crews may need to perform the day before for set up). We can also reimburse up to an additional \$1,000 for safety supplies needed for the demonstration (eye protection, gloves, safety helmets).

We can provide some flexibility in the date for the award letter to be signed, but we are asking by June  $\mathbf{1}^{\text{st}}$  because waiting longer will delay us being able to work on the project and push the timeline back.
