**MATANUSKA-SUSITNA BOROUGH
RESOLUTION SERIAL NO. 20-035**

A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE AMENDED BUDGET ON PROJECT NO. 45225, FUND 425, AMBULANCE REPLACEMENT/REMOUNT AND REFURBISH.

WHEREAS, with Ordinance Serial No. 16-092, the Borough accepted and appropriated a grant in the amount of \$35,000 to purchase a patient transport vehicle for the Lake Louise Ambulance Service; and

WHEREAS, the Lake Louise Ambulance Service is no longer operational and emergency medical services for that area are now under; and

WHEREAS, the active ambulance service areas for the Borough did not have a functional use for the patient transport vehicle and it was being left unused; and

WHEREAS, the Native Village of Ruby expressed an interest in purchasing the vehicle for their community in the amount of \$35,000, and so, a sale was made; and

WHEREAS, the Borough's Ambulance Service has an ongoing annual schedule for replacement/repair and refurbishment of their ambulances; and

WHEREAS, in fiscal year 2020, \$200,000 was appropriated to project no. 45225 to assist with the annual schedule for ambulance replacement/repair and refurbishment; and

WHEREAS, the funding received from the sale of the transport vehicle will be beneficial in assisting with the annual ambulance replacement/repair and refurbish schedule; and

WHEREAS, it is requested that the \$35,000 from the sale of the patient transport vehicle to The Native Village of Ruby, Alaska, be appropriated to the Ambulance Replacement/Remount and Refurbish Project, No. 45225-1830.

NOW, THEREFORE, BE IT RESOLVED, that the Assembly hereby approves the following amended budget for Project No. 45225-1830.
