

**SUMMARY STATEMENT:** Firewood harvest from the designated personal use firewood areas (PUFA) costs \$25 for the permit and \$25 per cord. The Land and Resource Management Division has concluded that waiving these fees until July 31, 2020 will help offset the potential economic impacts from the COVID-19 pandemic to Borough residents who routinely use wood as their primary heat source. There are currently four PUFAs open for general harvest and two open for the harvest of beetle kill spruce only.
