A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE SCOPE OF WORK AND BUDGET FOR FISH CREEK/JAY NOLFI PARK IMPROVEMENTS, FUND 480, PROJECT NO. 15050.

WHEREAS, the Assembly accepted and appropriated grant funds from the Mat-Su Trails and Parks Foundation for \$34,847.84 for Fish Creek/Jay Nolfi Park improvements in Ordinance Serial No. 20-038; and

WHEREAS, the fish viewing platform was vandalized last year leaving it in an unsafe condition; and

WHEREAS, the platform was removed in order to protect the public from injury; and

WHEREAS, a new steel platform and approach will be constructed as part of this project; and

WHEREAS, an Americans with Disabilities Act accessible pathway will be added to the platform and viewing area for the band shell; and

WHEREAS, additional improvements include replacing the fencing and shore stabilization with vegetative plantings; and

WHEREAS, the grant requires the Borough to provide a match of \$34,847.84; and

WHEREAS, the Borough will provide \$24,847.84 of in-kind match using project funds, which were approved by the Assembly in the fiscal year budget appropriation process; and

WHEREAS, \$4,890 of in-kind match funds will come from the Recreation Services Division fiscal year 2021 operating funds in the form of staff time and labor; and

WHEREAS, the Assembly has accepted and appropriated \$10,000 in community donations raised by the family of the late Jay Nolfi, to be used for improvements at the Fish Creek/Jay Nolfi Park.

NOW, THEREFORE, BE IT RESOLVED, that the Assembly hereby approves the following scope of work and budget for improvements at the Fish Creek/Jay Nolfi Park project, fund 480, project no. 15050.
