ORDINANCE SERIAL NO. 20-049**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY REAPPROPRIATING \$22,299 FROM FUND 475, PROJECT ACCOUNT 20392, TO TO FUND 440; PROJECT NO. 20203, HISTORIC PRESERVATION PLAN - PHASE II; AND \$50,557 FROM PROJECT ACCOUNTS 20392, 20393, AND 20397 FUND 475; TO FUND 480, PROJECT NOS. 47520, BOROUGH WIDE COMPREHENSIVE PLAN AND 47514, STORMWATER MANAGEMENT PLAN; AND MOVING \$49,073 FROM PROJECT NO. 47047 HOUSING ANALYSIS; AND \$40,370 FROM PROJECT NO. 45177 TRANSPORTATION ROW CORRIDOR PROJECT, FUND 480, TO PROJECT NO. 47520, BOROUGH WIDE COMPREHENSIVE PLAN UPDATE; AND EXTENDING ALL PROJECT AND SUB-PROJECT COMPLETION DATES TO JUNE 30, 2023.

WHEREAS, the Planning Department has identified four projects that were completed with funding remaining; and

WHEREAS, the Planning Department has identified a number of projects that need to be completed and are lacking funding, project nos. 20203 Historic Preservation Plan - Phase II, 47514 Stormwater Management Plan, and 47520 Borough Wide Comprehensive Plan Update; and

WHEREAS, these projects will not be completed by June 30, 2020, therefore, it is necessary to reappropriate funds into these project accounts and extend the expiration of these project accounts to June 30, 2023; and

BE IT ENACTED:

Section 1. Classification. This ordinance is a noncode ordinance.

Section 2. Reappropriation Source. The Assembly does hereby reappropriate \$22,299 in fund 475, from project account 20392 to fund 440, project no. 20203; and \$50,557 from project accounts 20392, 20393, and 20397, fund 475, to fund 480; project nos. 47520, and 47514; and moving \$49,073 from project no. 47047, housing analysis; and \$40,370 from project no. 45177 transportation right-of-way corridor project, fund 480 to project no. 47520, Borough Wide Comprehensive Plan Update; 20203 Historic Preservation Plan, Phase II; project no. 47514 Storm Water Management Plan.

Section 3 Expiration Date. The expiration date of project nos. 20203, 45002, 47021, 47038, 47052, 47513, 47514, 47520, and 47522, are hereby extended through June 30, 2023.

Section 4. Effective Date. This ordinance shall take effect upon adoption.


