**MATANUSKA-SUSITNA BOROUGH
ORDINANCE SERIAL NO. 20-054**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING AN ACCEPTANCE AND APPROPRIATION OF \$10,127.91 OF REVENUES FROM FISCAL YEAR 2020 PUBLIC DONATIONS INTO PROJECT NO.10151, FUND 435, AND REAPPROPRIATING \$25,000 OF FUNDS FROM THE FISCAL YEAR 2020 ANIMAL CARE AND REGULATION OPERATING BUDGET, FUND 200, INTO PROJECT NO. 10151, FUND 435, TO IMPROVE THE ANIMAL CARE FACILITY AND ENHANCE THE QUALITY OF CARE FOR SHELTER DOGS.

WHEREAS, the Animal Care and Regulation Division has received financial contributions from the public; and

WHEREAS, the donated funds must be accepted and appropriated; and

WHEREAS, \$10,127.91 of fiscal year 2020 public donations will be accepted and appropriated to project no. 10151, fund 435, to be used for building a covered dog walk area at the Animal Care and Regulation facility and remediating the black mold discovered in the area of the dog kennels; and

WHEREAS, \$25,000 of funds from the fiscal year 2020 Animal Care and Regulation operating budget, fund 200, will be reappropriated to project no. 10151, fund 435, to be used towards the covered dog walk and the black mold remediation in the dog kennel area; and

WHEREAS, adoption of this ordinance will place these funds into project no. 10151, fund 435, for improvements to the Animal Care and Regulation facility to improve the quality of care the shelter dogs receive.

BE IT ENACTED:

Section 1. Classification. This is a noncode ordinance. s

Section 2. Acceptance, Appropriation and Reappropriation.

The Assembly hereby approves and accepts the appropriation of \$10,127.91 of revenues from fiscal year 2020 public donations into project no. 10151, fund 435, and the reappropriation of \$25,000 of funds from the fiscal year 2020 Animal Care and Regulation operating budget, fund 200, into project no. 10151, fund 435, to improve the animal care facility and enhance the quality of care for sheltered dogs.

Section 3. Effective date. This ordinance shall take effect upon adoption.
