In consideration of the mutual understandings hereinafter set forth, the parties do hereby agree as follows:

- 1. The Matanuska-Susitna Borough is beginning the process to update the Historic Preservation component of the Matanuska-Susitna Borough Comprehensive Plan. MSB 15.24.030(B)(1).
- 2. The Knik Tribal Council and the Matanuska-Susitna Borough agree to cooperate on the update of the Matanuska-Susitna Borough Historic Preservation Plan.
- 3. The Knik Tribal Council agrees to provide cultural and historical information relevant to the update of the Matanuska-Susitna Borough Historic Preservation Plan.
- 4. The Matanuska-Susitna Borough agrees to list the Knik Tribal Council as a Partner in the update to the Matanuska-Susitna Borough Historical Preservation Plan.
- 5. No cooperation agreement previously entered into between the Matanuska-Susitna Borough and the Knik Tribal Council shall be construed to apply to any project(s) covered by this Cooperation Agreement.
- 6. This Cooperation Agreement shall not be abrogated, changed, or modified without the written consent of authorized individuals of both the Matanuska-Susitna Borough and the Knik Tribal Council.
- 7. This agreement constitutes an integrated agreement. No statements, either written or oral, prior to or contemporaneous with the execution of this document may be used to vary the terms hereof.

- 8. Each party agrees, by signature to this document, that it has had an adequate opportunity to review its contents and consult with any agent or advisor that the party deems necessary prior to execution and, in executing this document, is fully aware of all terms and conditions contained herein.
- 9. This Cooperation Agreement may be terminated by the Matanuska-Susitna Borough or the Knik Tribal Council for any reason and at any time upon notice to the other party. Each party agrees to provide a written notice of termination to the other party.

IN WITNESS THEREOF, the Matanuska-Susitna Borough and the Knik Tribal Council have respectively signed this Cooperation Agreement and caused their seals to be affixed and attested to as of the day and year first above written.
