The annual budget for the State Fair is over \$8 million and the deficit right now for the State Fair is \$1.3 million. Without assistance, the State Fair may never recover from the economic impacts from **COVID-19** related closures. The loss of the State Fair would be devastating to the over 400 vendors who participate. Over 2/3 of the vendors are small businesses in the Matanuska-Susitna Borough outside of the cities who depend on participation at the annual fair. This direct grant will give of up to \$450,000 in aid upon documentation of losses due to COVID-19 related closures. Money can be used to help support overall operations of the Alaska State Fair.
