RESOLUTION SERIAL NO. 20-092**

A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ALLOCATING HUMAN SERVICES COMMUNITY MATCHING GRANT FUNDS TO NON-PROFIT HUMAN SERVICE AGENCIES WITHIN THE COMMUNITY AND AUTHORIZING THE MANAGER TO ENTER INTO GRANT AGREEMENT WITH THE SUB-GRANTEE AGENCIES.

WHEREAS, grant funds from the Alaska State Department of Health and Social Services were accepted and appropriated by Ordinance Serial No. 20-074 for the Human Services Community Matching Grant Program; and

WHEREAS, Resolution Serial No. 20-075 designated \$296,807 in grant funds and \$127,203 in matching funds be awarded for the provision of services which are necessary to alleviate serious mental or physical hardship; and

WHEREAS, one of the duties of the Health and Social Services Board is to guide the allocation of grant funds; and

WHEREAS, a request for applications for a two-year grant cycle was distributed to nonprofit human service agencies, advertised in local newspapers, and posted on the Borough website, for the fiscal year 2021/2022 grant programs; and

WHEREAS, the fiscal year 2021 grant program is year one of the two-year cycle.

NOW, THEREFORE, BE IT RESOLVED, that the Assembly hereby allocates Human Services Community matching grant funds and

authorizes the Manager to enter into grant agreements with the sub-grantees as follows:

- \$47,210 to Mat-Su Senior Services for transportation and other services for seniors; and
- \$47,100 to MY House for the provision of services to homeless and at-risk youth ages 14-24; and
- \$47,100 to Valley Transit for transit services; and
- \$47,100 to Chugiak Children's Services Early Learning for family advocacy services for families of head start and early head start children; and
- \$47,100 to Wasilla Area Seniors for nutrition services for seniors; and
- \$14,130 to Access Alaska for unmet health and accessibility needs; and
- \$47,100 to Alaska Legal Services for free civil legal assistance for vulnerable households; and
- \$47,100 to Mat-Su Health Services for behavioral health services; and
- \$32,970 to Salvation Army for emergency and crisis assistance to families and individuals in need; and
- \$47,100 to Boys and Girls Club for the provision of mentoring and educational activities for Mat-Su Children.
