SUMMARY STATEMENT: The kennels at the animal care facility are in poor condition. Funds have already been approved by the assembly to upgrade the cat kennels and the cat kennel area, however, the dog kennels also need upgrades and restoration in order to meet best practices and safety standards. The dog kennels have a black mold issue in the walls that will cost more than initially anticipated to fix. According to best practices, shelter dog kennels should have an entrance door and a separate exit door, so that an employee or volunteer cannot get trapped in a kennel with an aggressive dog. The cost for upgrading and remodeling the kennel area is above the current project funds. This legislation will combine leftover funds from projects that were already completed and transfer funds that were designated for other projects.

**RECOMMENDATION OF ADMINISTRATION:** The administration recommends approving this legislation.
