MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 20-101

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY TO REAPPROPRIATE \$25,000 FROM PROJECT NOS. 25020-2402 AND \$40,542.05 FROM PROJECT NOS. 25035-2407 TO PROJECT NO. 25001, FUND 420, TO ALLOW FOR THE PURCHASE OF A WASTE CONTAINER ROLL-OFF TRAILER PUP.

WHEREAS, \$25,000 was appropriated in the fiscal year 2017 Capital Projects enterprise fund budget for project no. 25020-2402 for Shop Roof Extension And Repair, and

WHEREAS, due to operational changes this project has been cancelled with \$25,000 remaining, and

WHEREAS, \$350,000 was appropriated in the fiscal year 2017 Capital Projects enterprise fund budget for project no. 25035-2407 for Transfer Site Upgrades, and

WHEREAS, this project is now complete with \$51,291 remaining, and

WHEREAS, the Solid Waste Division is in need of an additional waste container roll-off trailer pup to meet the increased demands of hauling waste from MSB Transfer Stations to Central Landfill; and

WHEREAS, the Solid Waste Division obtained a quote to include freight for a TT-OR-176 Pup through Sourcewell cooperative purchasing program (formerly National Joint Powers Alliance) totaling \$62,421; and

WHEREAS, combining the remaining funds from these completed Solid Waste capital projects will provide the Solid Waste Division with enough funds to complete the purchase of the trailer pup to include a 5 percent contingency for any unforeseen rate changes to shipping and/or manufacturing costs.

BE IT ENACTED:

Section 1. <u>Classification</u>. This Ordinance is a noncode ordinance.

Section 2. <u>Acceptance and Appropriation Source</u>. The Assembly hereby reappropriates \$25,000 from project no. 25020-2402 and \$40,542.05 from project no. 25035-2407, to project no. 25001, fund 420, for the purchase of a waste container roll-off trailer pup.

Section 3. <u>Effective Date</u>. This ordinance shall take effect upon adoption.
