## MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 21-031

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$28,042.17 FROM THE ALASKA STATE DIVISION OF FORESTRY VOLUNTEER FIRE ASSISTANCE GRANT PROGRAM, AND APPROPRIATING \$2,804.23 IN MATCHING FUNDS TO PROJECT NOS. 20144, 20151, 20150, 20145, 20255, AND 20146, ALL FUND 405, FOR FIREFIGHTER AND FIREFIGHTING EQUIPMENT, SUPPLIES, AND CLOTHING.

WHEREAS, the Borough fire services areas have been awarded grant funds from the Alaska State Division of Forestry Volunteer Fire Assistant grant program in the amounts of \$4,970.70 for Butte, \$4,885.65 for West Lakes, \$4,988.39 for Caswell, \$5,000 for Talkeetna, \$3,224.00 for Sutton, and \$4,973.43 for Willow, for a combined total grant award of \$28,042.17; and

WHEREAS, the fire service areas must provide 10 percent matching funds in order to comply with the conditions of the grant and to receive the grant; and

WHEREAS, the scopes of work and budgets are contained in Resolution Serial No. 21-027; and

WHEREAS, the acceptance and appropriation of the grant funds serves a public interest.

BE IT ENACTED:

Section 1. <u>Classification</u>. This Ordinance is a noncode ordinance.

Section 2. Acceptance and Appropriation Source. The Matanuska-Susitna Borough Assembly hereby accepts and appropriates grant funds in the combined amount of \$28,042.17 from the Alaska State Division of Forestry Volunteer Fire Assistant grant program and approves appropriations from the following fire service area fund balance accounts: Butte - fund 251, \$497.07 to project no. 20144; West Lakes - fund 249, \$488.57 to project no. 20151; Caswell - fund 248, \$498.84 to project no. 20150; Talkeetna - fund 254, \$500.00 to project no. 20145; Sutton - fund 253, \$322.40 to project no. 20255; and Willow - fund 258, \$497.35 to project no. 20146; to purchase firefighter and firefighting equipment, supplies, and clothing.

Section 3. <u>Effective Date</u>. This ordinance shall take effect upon adoption.
