A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY AMENDING THE SCOPE OF WORK AND BUDGETS FOR PROJECT NO. 20398 HUMAN SERVICES COMMUNITY MATCHING GRANT FISCAL YEAR 2021, PROJECT NOS. 47520-4200-4205 ZONING CODE UPDATE, AND 45002 CENSUS, AND EXTENDING TIME OF COMPLETION ON FUNDING TO JUNE 30, 2025.

SCOPE OF WORK - PROJECT 45002 CENSUS

All funding will be used as needed to support the Redistricting/Reapportionment processes, this will include, specialized redistricting software, a contractor with the knowledge to assist and provide guidance for completing the reapportionment plan and a contract to writing the legal descriptions for the assembly districts in the reapportionment plan.


