**MATANUSKA-SUSITNA BOROUGH  
ORDINANCE SERIAL NO. 21-050**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$20,980 FROM THE MAT-SU TRAILS AND PARKS FOUNDATION TO PROJECT NO. 15040, FUND 440, TO CONTINUE DEVELOPMENT OF SETTLERS BAY COASTAL PARK.

WHEREAS, the Community Development Department applied for a grant from the Mat-Su Trails and Parks Foundation for Settlers Bay Coastal Park; and

WHEREAS, the Mat-Su Trails and Parks Foundation approved the application and awarded Grant No. 2021-301 in the amount of \$20,980; and

WHEREAS, the grant requires the Borough to provide a match of \$10,490; and

WHEREAS, The Community Development Department will provide an \$8,000 cash-match from project no. 15040-4200-4203, fund 440; and

WHEREAS, in-kind match will also be provided by the Borough, which includes the donation of large boulders to be used as traffic controls and staff labor costs from Land and Resources Management staff and the Borough Trail Crew; and

WHEREAS, the grant funds will be used to continue to develop the park in accordance with the conservation easement and adopted

the Recreation Development Plan, with an expected completion date by the end of 2021.

BE IT ENACTED:

Section 1. Classification. This Ordinance is a noncode Ordinance.

Section 2. Acceptance. The Assembly hereby accepts \$20,980 from the Mat-Su Trails and Parks Foundation for continued development of Settlers Bay Coastal Park.

Section 3. Appropriation Source. There is hereby appropriated by the Assembly \$20,980 from the Mat-Su Trails and Parks Foundation, to project no. 15040, fund 440, for continued development of Settlers Bay Coastal Park.

Section 4. Effective Date. This ordinance shall take effect upon adoption.
