## XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Assemblymember Hale spoke in support of residents using transfer stations. Opined that the proposed resolution was the wrong way to go about it. Stated that he has been working with staff to figure out ways to reduce taxpayer burden.

Assemblymember Nowers spoke to the need to ensure that all decisions made impact residents fairly across the board. Stated that she is interested in what the Borough might accomplish with opioid funds. Noted that she requested that "Possible Legislative Priority: Healthcare Pricing Transparency" be added to joint agenda for discussion. Spoke to difficulties that she has encountered in trying to determine prices of services before they are received. Thanked staff for the redistricting update. Stated that she would like updated maps as information changes.

Assemblymember Sumner related that he has had a lot of contact from residents speaking in opposition to the Borough enacting a vaccine mandate or lockdown. Stated that the Borough does not have health powers and cannot mandate any such thing.

Ms. McKechnie spoke to the way that the state does redistricting and how reapportionment for the Borough will work. Advised that she is looking at a possible special election in April for the voters to ratify the proposed reapportionment.

Assemblymember Tew spoke to concerns with fees collected at the landfill. Opined that the Borough is the highest in the Nation for the use of landfills.

Assemblymember McKee stated that he is astounded that the Assembly believes they cannot ever close Port MacKenzie.

Assemblymember Boeve stated that she has been hearing from her constituents quite a bit in regard to the lack of COVID testing places in the northern communities. Stated that she is not sure if that is anything the Borough can do to assist with that, but that it would be nice if testing were more accessible in the northern areas.

Mayor Halter stated that he is pleased that the funds for pile sleeves have been secured. Noted that this has been an issue for a very long time. Stated that he likes the idea of working with the Denali Borough regarding redistricting. Spoke to what he pays for in trash collection fees. Noted that at one time, the Landfill enterprise fund was in the red. Stated that he would hate to see the fund go back in the red. Advised that the Iditarod Burma Road underpass issue was litigated all the way to the Supreme Court.
