**SUMMARY STATEMENT:** On August 3, 2021, through Resolution No. 21-071, the Assembly approved the scope of work for the anticipated rental income during FY22 from the properties acquired as right of way for the Rail Extension Project from Port MacKenzie to the Mainline, Project No. 75001. The attached resolution will, if approved, amend the scope of work to include wages and benefits for an after-hours initial responder to emergencies occurring at the Port MacKenzie Rail Extension rental properties.

Matanuska-Susitna Borough (MSB) employee, Toby Riddell, currently works as an on-call Building Maintenance Specialist at Port

MacKenzie. He has agreed to be the after-hours contact and initial responder for rental properties the MSB has acquired as part of the Port MacKenzie Rail Extension project. This resolution is necessary to add payment of his wages and benefits for the time he works on this project.
