Mr. Spiropoulos advised that the Alaska State Redistricting Board just released a new map at their most recent meeting.

Assemblymember Sumner advised that local improvement districts do not benefit developers therefore most will not do them.

Assemblymember Nowers spoke in support of replacing culverts to increase fish passages. Spoke in opposition to the increase to the percentage threshold for local improvement districts. Spoke to the need to protect the asset that is Port MacKenzie. Requested an economic impact report at the next meeting.

Assemblymember Yundt noted the growth in population that the Borough continues to experience. Stated that he understands the concerns about Port MacKenzie and noted that it is the most valuable piece of property that the Borough owns. Commented that the Borough may need to consider putting out a request for proposal in the future to see if there is any interest in a private company managing and maintaining the port. Related that as a developer, he does not engage in local improvement districts, as they are detrimental to his business. Noted that the possible gravel tax would hurt developers the most as they always need gravel. Stated that he did not run for office to make money, but to support his community.

Assemblymember McKee opined that the Borough needs to ensure that the port is a viable marketing option before any additional funds are spent on it, because it is a waste of money when there are no customers. Stated that he wants to see the State's share of the funding for the Arctic Winter Games before the Borough dedicates any more funds toward it, as he does not trust them to come through with the funding as promised.

Mayor Halter stated that when his term ends, that he would miss Assemblymember McKee's passion. Thanked Ms. Loscar for her comprehensive and professional report. Opined that the Burma Road Iditarod Trail Under Pass will be used by many user groups. Stated that he is very proud to have helped get this crossing in order to ensure the safety of trail users. Thanked Mr. Smoldon for attending meetings and keeping the Assembly up-to-date on the activities of the Legislature and Governor Dunleavy.

There was no executive session.
