In response to God's call to plant a church at 20451 Caswell Lakes Road, I purchased said land in March 2006 and move here in May 2006. In July 1, 2007, I was ordained as a pastor. In order to get to know the people of the community by being a blessing to the community, in April 2008 with the help of 6 members of the community we initiated a Neighborhood Watch and Telephone Tree. The telephone tree enabled us to have a point of contact in case of fire and to secure immediate help in fighting a fire in the hope of preventing it from spreading. On July 13, 2008 regular worship services began at Christ-Centered Community.

Cooperating with God in planting a church and in transforming the Caswell area from the bad lands of Alaska into a safe place for people to live and to be part of a community that will go out of its way to help one another has been a rewarding challenge. A major step in that challenge playing a part in the Caswell Fire Service Area becoming a reality. Being a woman of 58 years of age called to plant and pastor a church in this rural community I felt I had neither the physical ability nor the time to be adequately trained to be a volunteer fire fighter in the Caswell Fire Service Area. On the other hand, wanting to play a part in this important endeavor, I felt that I could contribute in an area that would require less of my time and in which my occupational experience and education might qualify me; that area being as a member of the Board of Supervisors. As such I applied for and was appointed to the Board on April 7, 2009. I served on and was the Chairman of the Board until December 31, 2018. In need of a break I did not reapply for another three year term; however, after having had a yearlong break and after having heard the Board is in desperate need of a third board member, I reapplied and was reappointed for a term of January 1, 2020 - December 31, 2021. Since that term is coming to an end I am reapplying at this time in the hope of being afforded the opportunity to continue participating in growing and maintaining a volunteer fire department in the Caswell Fire Service Area that can be a blessing to the entire community.
