XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Mr. Spiropoulos thanked the body for the positive evaluation.

Ms. McKechnie noted that due to School Board seats being districted, which were previously an areawide issue, that potentially there could be precincts that may have nothing to vote on and advised as to the process she intended to use should that be the case.

Assemblymember McKee spoke to concerns with the funds spent on lobbyists.

Assemblymember Sykes noted he had the same question as Assemblymember McKee. Noted that the emergency repair to save the highway from the Matanuska River is currently experiencing scouring under the armor rocks. Opined that the Matanuska River may be a candidate for a private program in which volunteers do bank stabilization. Noted that the Federal Bureau of Land Management sent out a news release that the Knik River is navigable all the way to Knik Glacier. Spoke to the need to be cautious with changes to Title 43. Opined it was a good meeting and congratulated Mr. Spiropoulos on a successful review.

Assemblymember Kowalke congratulated Mr. Spiropoulos on a successful review. Mentioned that June 6 is the anniversary of the D-Day invasion. Thanked veterans for their service. Assemblymember Kowalke spoke to concerns with the changes needed to Title 43.

Assemblymember Mayfield thanked Mr. Krug for his testimony. Thanked the body for supporting Ordinance Serial No. 17-060. Thanked the public for testimony.

Assemblymember Colligan spoke to enjoying evaluating Mr. Spiropoulos. Thanked him for his service. Stated that he has really appreciated his efforts over the years. Spoke in support of Mr. Spiropoulos' personality and unique skills and the overall great service from the Law Department. Related that initially, he had concerns about the land acquired through Ordinance Serial No. 17-060. Noted that his concerns were assuaged when
