Ms. McKechnie reported on the steps that are being taken to notify voters that there will be some precincts that have nothing to vote on, due to the fact that there are no areawide questions on the Borough ballot this year. Stated that those voters will be receiving a notice from the Clerk's Office and that there is also advertising that is occurring.

Mr. Spiropoulos thanked the body for a good meeting.

Assemblymember McKee spoke to his concerns with not being able to hear some of the testimony provided by the public.

Assemblymember Sykes opined that it is an interesting concept that if a buyer does not use a plastic bag at the grocery store, that they would not have to pay bag tax. Spoke to the ribbon cutting for West Butte Trailhead. Thanked the body for the meeting.

Assemblymember Mayfield thanked Assemblymember Doty for bringing the plastic bag ordinance forward. Related that although he does not agree with the tax, that he appreciates the discussion of how to reduce plastic bag waste. Spoke to the need to engage the public in recycling. Opined that there was a lot of good discussion this evening.

Deputy Manager Hayes advised that the Assembly will have answers to questions on AM 17-082 prior to the next meeting.

Presiding Officer Kowalke thanked the body for the privilege of being Chair. Stated that he hopes that the job he did as Chair meets the satisfaction of the body.
