XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Mr. Moosey stated that he has appreciated the way the public has respectfully interacted with him regarding the contentious issue of air quality. Noted that he appreciates the courtesy that has been extended to him.

Assemblymember Doty thanked the audience for their testimony. Stated that air quality is an important but complicated issue. Advised that there has been a 31 percent increase in death related to lung diseases since 1972. Noted that it is important to mitigate the impact to the health and welfare of the public.

Assemblymember Leonard noted his agreement with Assemblymember Doty. Stated that he needs more information before he can make an educated decision on air quality. Expressed congratulations to Mr. Moosey and Ms. Heindel on the successful financial audit.

Assemblymember McKee spoke to the need for people to burn dry wood.

Assemblymember Sykes spoke to his appreciation of the public testimony provided this evening. Stated that he did not appreciate all the misinformation being passed around on social media that stated that the Borough is making plans to take away residents' wood stoves. Stated that is not something that the Borough would ever do. Commented that the Assembly cannot make public policy based on misinformation. Opined that it is better to have a local option. Noted that there is a lot of data on the subject of air quality and that the body needs to become familiar with it. Spoke in support of the Borough not being impacted by Federal air quality regulations.

Assemblymember Kowalke spoke to concerns with how the 2006 Memorandum of Understanding is currently impacting the Borough. Opined that the air quality monitoring stations are in the worst possible locations. Spoke to the need to make sure that local options are in place. Spoke to misinformation provided on social media on this issue.

Assemblymember Mayfield opined that the Borough could engage in a war regarding federal oversight of air quality but that the cost to tax payers would be too high. Stated that it is important to make informed decisions and not blindly follow the pack. Wondered if the air quality monitoring stations were placed where they currently are for a specific reason, such as to measure and demonstrate a problem of a specific area. Noted that staff told the Assembly that there is a demonstrable air quality problem, but he is not sure everyone listened. Opined that there needs to be a Memorandum of

Understanding so that the Borough has negotiating leverage. Spoke to the possibility of creating air quality districts. Spoke to the needs to educate residents on how to burn when there is an air quality concern. Expressed concerns that an area that has air quality issues could impact and area that does not, due to the size of the Borough. Thanked the public for their testimony. Spoke to concerns with misinformation that was spread around on social media. Opined that it was an egregious act to spread around that the Borough was moving to take away residents' woodstoves.

Assemblymember Beck spoke to concerns with the current Memorandum of Understanding. Spoke to concerns that if there is no plan in place that it could have a significant financial impact on residents. Opined that the public testimony this evening brought some good questions forward. Noted that there are many things to address before the Assembly moves forward. Stated that there is no conspiracy to take wood stoves from residents. Spoke to his desire to serve the people of the Borough in a positive way. Spoke to his appreciation of the testimony this evening, except for some testimony that crossed the line and was inappropriate for a public venue.

Mayor Halter thanked Ms. Heindel for a successful audit. Opined that the Borough is going in the right direction. Stated that there has never been an intention to take away residents' right to heat their homes with a wood stove. Stated that Mr. Moosey is going in the right direction in working with the public. Commented that the Borough's population is growing and that there will be more residents who will be using wood to heat their homes. Noted that the air quality issue is going to have to be dealt with sooner or later. Spoke to his history of burning wood for heat. Stated that he still splits and uses wood for heat. Noted that Fairbanks fought the air quality issue and it cost them in the end. Agreed that someone spreading false information across social media that the Borough is working at taking wood stoves from residents was a shameful move. Stated that although it was a tough meeting that he appreciates the public testimony and thoughtful discussion.
