Assemblymember Leonard queried that if he wanted to sponsor that legislation, when would it be due.

Ms. McKechnie stated that the Clerk's Office would need to have the title by Wednesday afternoon in order to advertise it.

Mr. Moosey thanked the body for the meeting. Stated that he will provide detailed information to the Assembly regarding the capital projects that are the subject of Ordinance Serial No. 19-060.

Assemblymember Sykes noted that information regarding the capital projects was include in its accompanying Informational Memorandum.

Mr. Mayor stated that he would like to have more information regarding the possible rock quarry at Wolverine Lake.

Mr. Moosey noted that surveying the possibility of that quarry was intended to see if it could generate revenue and not to destroy a neighborhood.

Assemblymember McKee stated that he is concerned about passing contracts without written project analysis attached.

Assemblymember Sykes noted that there has been a lot of activity in spring clean ups. Congratulated all the 2019 graduates.

Assemblymember Boeve noted that June 14 is the 4-year anniversary of the Sockeye Fire. Urged residents to call the burn hotline before any burning is done.

Assemblymember Mayfield noted differences in perspectives on replacement of fire equipment. Summarized his history of working with fire departments. Noted that there are remote areas that need proper equipment and that he is in support of that.

Assemblymember Sumner stated that he would like more in depth conversations about capital project completion time lines. Congratulated Assemblymember Sykes for being voted as Best Elected Official.

Assemblymember Leonard congratulated Assemblymember Sykes. Noted

that he does work hard for his constituents. Requested that members get their budget amendments in by Friday morning, so that they can be looked at over the weekend. Stated that he needs to be able to vet their impacts before he makes a decision. Stated that he does not feel right voting on amendments until he understands how they impact services and residents. Stated that he is in support of legislation that would prohibit a sitting member of the Assembly from entering into contracts with the Borough. Spoke to the need for more stringent controls over capital projects.

Ms. McKechnie advised that if there are any budget amendments, to get them to the Clerk's Office by Friday morning, as this would facilitate Ms. Heindel reviewing them and providing them to the Assembly and the public.

Assemblymember Beck spoke to the graduations that he attended last week. Noted it was inspiring to see the accomplishments the kids had made. Encouraged the Manager and the Assembly to have a broad vision as the budget process moves forward. Spoke to the need to be creative.

Mayor Halter stated that he will be attending the Memorial Day ceremony at the Veteran's Wall of Honor. Related that he will be writing a letter to State Legislators regarding the fact that because they have not kept their budget deadlines that it is impacting the Borough's ability to do so. Thanked Mr. Hays and the Police Powers Task Force for their ongoing work. Spoke in favor of amending the Fiscal Year 2020 budget with the Fiscal Year 2019 budget adopted. Noted that he is looking into making that happen.
