VII. MAYOR, ASSEMBLY, AND STAFF COMMENT

Ms. McKechnie advised that she had researched the cost of portable equipment to live stream Assembly meetings when they are held outside of Assembly Chambers. Noted that the Assembly typically has three offsite meetings per year. Noted that the cost for that type of equipment would be nearly \$25,000. Related that she did not intend to spend that amount of funds at this time, when there are other more important things that are needed during this budget crisis. Noted that if that is something the Assembly would like her to pursue that she would do so with their direction.

Mayor Halter stated that he would like to schedule one last budget meeting for June 3, 2019, at 6 p.m. in case it is needed. Queried if there was any objection.

There was no objection noted.

Assemblymember McKee noted that budget meetings are productive. Opined that when someone suggests full funding for a project, that they should make a suggestion as to what is cut or how it can be funded.

Assemblymember Leonard thanked the public for attending and providing comment. Spoke to concerns that with the current Manager's proposed budget, that the mill rate will have to go up. Related that his constituents are saying they cannot afford an increase in their property taxes. Spoke in support of increasing Code Compliance enforcement.

Assemblymember Sykes spoke to concerns with what services could possibly be eliminated. Spoke to how the disabled veterans and senior citizen tax exemption functions and what portion of it is state mandated. Stated that the Borough does not have an obligation to fund emergency services. Noted that education has always been a priority to the Assembly. Noted that the Assembly adopted an ordinance that gave the School District their lapsed funds. Spoke to a recent meeting he had about diversifying the Borough's tax base. Commented that property tax owners bear the brunt of paying the cost of services needed in the Borough. Spoke to all the taxes that have been discussed. Spoke in support of a sales tax.

Assemblymember Beck stated that he admired Assemblymembers Mayfield and Boeve having the courage to stand their ground. Stated that the best comment he heard was to take concerns with education to the School Board as it is not the Assembly's job to micromanage the School District. Opined that parents are children's primary educator and should work in partnership with the School District to make that happen. Opined that it is not fair to point fingers at the School District when parents play a part in their

children's education. Commented that the Manager has proposed a budget that he assumes will be reality. Opined that as proposed, it reflects that the Borough is attempting to be living within our means.

Mayor Halter stated that this is his eleventh budget season and that it has also been the most difficult. Noted the difficulty in crafting a budget when it is not known what will come out of Juneau. Noted that the Assembly has no intent to shift school bond debt reimbursement to the School District. Spoke against getting into a constitutional debate about the permanent fund dividend (PFD). Spoke in opposition of larger class sizes. Noted that the Assembly has always fully funded the School District. Summarized impacts that could occur to meet new challenges and cuts to services. Stated that operations and services can only be reduced so far before Borough employee moral plummets. Noted that it is the State's responsibility to fund schools. Reiterated that the Assembly always makes sure the School District receives the funds they need. Opined that the PFD debate is unnecessary. Related that he does not want to close out the budget cycle until we know what Juneau is doing and that is why he requested the extra meeting.
