## VIII. MAYOR, ASSEMBLY, AND STAFF COMMENT

Mr. Spiropoulos stated that if the body had any questions regarding any topics discussed this evening, to please let him know. Noted that the legislature has the power to call themselves into special session. Related for that to happen, it requires 40 votes. Spoke to the environmental impact statement (EIS) that has come out regarding Port MacKenzie. Noted the direction provided to the Manager does spill over into the Law Department. Spoke to how he intends to handle special projects or contracts brought to him by the Manager.

Mr. Moosey thanked the body for clarifying how they wanted him to move forward on projects. Advised that the Montanan Creek Fire is now estimated at 300 acres.

Ms. McKechnie advised that she had hired a Deputy Clerk, Ms. Kelly Johnson, who comes with a lot of election experience.

Assemblymember Sumner noted that he felt the Assembly had somewhat paralyzed the Manager by their budgetary actions. Spoke to the importance of not ignoring potential projects.

Assemblymember Sykes summarized the history of the Port MacKenzie issue regarding the Federal Energy Regulatory Commission. Spoke to the possibility of conducting future studies regarding the shoal at Port MacKenzie. Thanked the body for the meeting.

Assemblymember Leonard wished the body happy July 4th. Thanked all military members for their service. Stressed that the Assembly did not approve or take any direction on any project. Noted that it was just to clarify to the Manager that he has the authority to move forward with bringing projects to the Assembly. Thanked Mr. Spiropoulos for the presentation regarding the special session location.

Assemblymember Boeve spoke in appreciation of the information received. Spoke in opposition to the date of the special meeting. Noted that her thoughts are with the northern communities during this time.

Assemblymember Mayfield spoke to the difficulty of trying to attend the meeting this evening. Questioned the necessity of the meeting being called on such short notice. Opined that it could have been done at a later date. Requested that unless it is an emergency, to please do not call a meeting on such short notice unless it is an emergency or there is actual business. Wished the body a safe and happy Independence Day.
