Assemblymember Nowers stated that she would be willing to help to trouble shoot any future call in meetings. Stated that she will attend in person for Thursday and the press conference on Wednesday.

Assemblymember Hale noted that it was a rocky start to the beginning of the meeting. Stated that things are working as best as possible for being a new way of doing things. Stated that he will not be able to call into the meeting on Thursday as he will be working.

Assemblymembers Leonard thanked the Clerk's Office for their tremendous effort in trying to make the meeting work with social distancing. Thanked all essential workers who are working during the pandemic. Spoke to his appreciation of the dedication of health care workers.

Assemblymember Boeve thanked Ms. Henry for her extra effort trying to make the meeting work. Noted that it was hard to hear at times, but that she understands this is a brand new process and it will take a few trial runs to cinch down a good process.

Assemblymember McKee opined that it is a waste of time to hear budget presentations as there is no money coming in from the State. Stated that oil prices are at an all-time low. Related that he will oppose any increases in the mill rate. Opined that a budget decrease of 10 percent is ideal. Noted that he only objected to the consent agenda because of AM 20-019. Opined that there are plenty of engineers on staff and that the Borough should not have to contract out for engineering work. Congratulated Mr. Moosey for being hired as City Manager with the city of Palmer. Stated that Mr. Moosey has done a fine job in addressing all of his concerns over the years.

Assemblymember Sumner noted that he wants to reconsider AM 20-019. Stated that he is hopeful that we can get through this crisis soon while there is still an economy. Opined that no matter what, the Borough will be facing steep headwinds and should look for ways to tighten up our spending.

Assemblymember Mayfield noted that humans are social animals and that the COVID-19 is causing hardships due to social distancing. Stated that the Clerk's Office is working to try to ensure the public is able to participate in this time of social distancing. Stated that he is hopeful that the system will be improved by the next time the Assembly is receiving public testimony.

Mayor Halter stated that reconsideration of AM 20-019 would be taken up on April 21, 2020. Advised members that they have many opportunities to
