XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Mr. Spiropoulos summarized the process of hiring a professional search firm to assist in the hiring of a new borough manager.

Assemblymember Leonard stated that he hopes everyone is taking appropriate safety precautions. Noted that he is looking forward to opening the economy in a safe manner.

Assemblymember Sumner stated that his is looking forward to moving forward with the Memorandum of Agreement with Alaska Industrial Development and Export Authority. Spoke to concerns with the speed with which unemployment is plummeting and how that impacts property tax.

Assemblymember Hale thanked staff for putting the meeting together in a way that the public is able to testify telephonically. Opined that the meeting went much more smoothly than the last. Spoke to his concerns with suspending rules on procurement. Related that was the only reason he opposed the motion to hire a professional search firm. Spoke in support of how Anchorage conducts its telephonic meetings. Stated that he would like to have public hearings on each piece of legislation and not lumped together.

Ms. McKechnie spoke to the intentions for moving forward with telephonic participation for Assembly meetings and having individual public hearings.

Assemblymember McKee opined that now is the time for the Borough to begin looking at options for reduction of property tax for small business. Stated that small business is taking the brunt of the economy due to Governor Dunleavy's health mandates. Opined that small business will be the first to close. Opined that the Borough needs to look at other ways to fund the Borough's budget.

Assemblymember Mayfield noted his agreement with Assemblymember McKee regarding the concern for small business. Noted the need to look at other ways to fund the Borough's budget. Stated that it would be unfortunate to have to delay capital projects which would put folks back to work, should there be no funding for them. Spoke to the possibility of having someone look at the budget to determine where cuts could be made. Thanked the body for the meeting.

Mayor Halter stated that he would like for each member to put together their thoughts about the budget and what ideas you have to make cuts. Spoke to the lack of funding from the State and to concerns of how to replace it. Spoke to concerns with how Covid-19 has impacted his own personal small

business. Related that he knows firsthand what an impact it is having on all small business. Stated that he is looking forward to the results of Assemblymember Nower's survey.

Spoke to plummeting oil prices and to concerns with the stock market impact on the permanent fund dividend. Thanked staff for their hard work on trying to make the meeting work. Spoke to the need for more public participation.
