Mr. Spiropoulos advised that the amendment to RS 20-096 about requesting the Legislature amend Title 29 to allow the Borough to elect a sheriff, that the Borough already has that power.

Assemblymember Sumner stated that was not the information he was provided, but that if it is true, then the Borough has already accomplished a priority in the legislation.

Assemblymember Halter opined that the Assembly has done a lot of good with the CARES Act Funds. Noted that most of the funding has gone to small businesses and not to working folks. Related that the city of Wasilla is looking at establishing a utility assistance program and that he would like to see the Borough do the same.

Assemblymember Nowers stated that she is glad to see the Willow Library project get started. Spoke to her virtual attendance at a recent high school swim meet. Noted that the lighting in the pool area is so much better since it has been remodled. Stated that although this has been a tough year, that there have been a lot of good things happening

Assemblymember Mayfield spoke to his reasons for resigning from the MSB Fish and Wildlife Commission. Opined that the Commission deserves someone who can dedicate more time to the cause as the work is very important. Summarized a list of accomplishments of the Commission. Wished the Commission well. Thanked the Mayor for the opportunity to serve on that commission.

Mayor Halter noted that there was a Police Powers Committee and that the body should follow that advice. Noted that was not put before the voters this year due to COVID. Requested Ms. Heindel report on what CARES Act funds still need to be allocated.

Ms. Henidel provide a staff report.

Mayor Halter noted that the ground breaking for the Willow Library was fun and well attended. Spoke to his amazement on how quickly the old library was taken down. Spoke to his pleasure that the project is well under way.
