#### XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Mr. Spiropoulos advised to let him know if any members have questions about the euthanasia legislation.

Mr. Hays stated that he has enjoyed being Interim Borough Manager. Thanked Mr. Krafft and his staff for their support during that time.

Ms. Henry thanked the body for their patience with her while she performed double duties.

Assemblymember Sumner spoke to confusion about veto powers.

Mr. Spiropoulos advised that per Borough code, the Mayor may veto any ordinance, resolution, motion, or other action of the Assembly.

Assemblymember Hale welcomed Assemblymembers Yundt and Tew. Noted that trapping season is in full swing. Related that a friend of his was out hunting with his dog and that the dog got caught in a conibear trap. Stated that anyone who spends time on trails or in the woods with their pets should learn to open them.

Assemblymember Yundt thanked the body for the meeting. Spoke to being passionate about keeping kids active. Stated that he fully supports the Borough hosting the arctic winter games.

Assemblymember Nowers welcomed Assemblymembers Yundt and Tew. Thanked Ms. Henry for covering the meeting. Spoke to her concerns about the shooting range legislation. Noted that it is a delicate subject and it is difficult to find a perfect balance. Stated that she does not want to impede new ranges, but that she would like to protect neighbors with concerns about shooting ranges so near their homes. Stated that her hope is that everyone can work together to put the pressure on the Alaska State Department of Natural Resources to develop more gun ranges. Spoke to her appreciation of the Assembly being passionate advocates for issues that affect the community.

Assemblymember McKee advised that he was not being duplicitous by voting yes on legislation in order to file for reconsideration. Stated that he would like to see safe shooting ranges in the Borough. Wondered if existing ranges should not be grandfathered in, in case they are not operating properly. Opined that the Borough's shooting range legislation is overdone. Related that Fairbanks has a shooting ordinance, but that it is less restrictive. Opined that way too much money is spent on building schools. Spoke to cost overruns that push the expense to build schools way over the
