XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Mr. Brown noted that wildfire risk reduction was a strategic priority of the Assembly and that is why Ordinance Serial No. 21-092 was brought forward for consideration. Stated that it was not to raise revenue.

Assemblymember Hale apologized for being late.

Assemblymember McKee noted his surprise about a possible wood chipping venture. Noted that there is no way to load wood chips on a ship until the conveyor belt is repaired.

Assemblymember Tew opined that it was a great thing to lower the rate for trash disposal. Spoke to concerns that the tall structure legislation may be putting the Talkeetna balloon company out of business.

Assemblymember Yundt spoke in support of the timber legislation. Spoke to concerns with the quality of the wood available to be salvaged. Stated that wildfires are a major concern of his. Spoke to the need to get the conveyor belt fixed.

Assemblymember Nowers spoke to the possible opioid settlement funds that would come to the state of Alaska. Noted it would be a small annual amount that the Borough would receive. Commented that she is pleased that a lot of thought was put into the infrastructure package. Noted her frustration with amending landfill rates without any justification. Opined that there should be a reason why the body does things and that it is a bad precedent to just do them for no reason.

Assemblymember Boeve advised that the balloon business in Talkeenta never materialized. Stated that it is fair to say that she has the most wildfire experience of anyone on the Assembly. Noted that she clearly understands wildfire risk. Advised that the Sockeye Fire was not due to beetle-killed spruce. Spoke to concerns that the Assembly does not always take the advice of advisory boards. Spoke to the importance of the public process.
