XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Mr. Brown advised that the Alaska Railbelt Clean Energy Infrastructure Growth Cluster grant application was submitted to the United States Economic Development Administration today. Stated that there letters of support were received from Governor Dunleavy, Senator Lisa Murkowski, Senator Dan Sullivan, Congressman Don Young, Representative Bart LeBon, Representative Steve Thompson, Representative Mike Prax, Representative Grier Hopkins, Representative Adam Wool, Representative Mike Cronk, Senator Scott Kawasaki, Senator Robert Myers, Senator Click Bishop; the cities of Fairbanks, Houston, Palmer, and the Denali Borough; the Fairbanks Economic Development Corporation, the Greater Wasilla Chamber of Commerce, Knik Tribal Council, and the Palmer Chamber of Commerce.

Assemblymember Yundt noted Mayor Halter's many years of service and stated that in all good conscience, he could not vote to override the mayoral veto. Stated that transfer fees could be discussed during the budget cycle.

Assemblymember McKee spoke to a conversation he had regarding the Assembly's view of the Borough's economy. Opined that the Assembly cannot give direction to the Manager without establishing that point of view. Further opined that it is a disserve the community.

Assemblymember Sumner noted that the Borough has been more economically sound over the last six years than many other parts of the country. Opined that it is not the Assembly's responsibility to predict what the economic future will be.

Assemblymember Nowers noted that areas that are thriving have looked at what they can do to attract business. Opined that there is no need to be in competition with Anchorage as what benefits the Borough may benefit them as well. Noted that everyone is concerned with energy and transportation costs. Spoke to the need for the Borough to retain what attracts residents to live here. Stated that she appreciated the presentations at the earlier meeting. Noted her pleasure that the C-Pace legislation was adopted. Stated that she is pleased that Mr. Jim Varsos was recognized. Spoke to a neighbor of hers that recently passed, Mr. Elliot Gagnon who was an Anchorage plastic surgeon with a long history of serving his community.

Mayor Halter spoke in appreciation of the presentation by Mr. Neal Fried. Spoke to the division of the bodies in Anchorage and in Palmer. Stated that he does not see that in the Borough's Assembly. Noted that he sees a lot of hard work and respect amongst the body. Stated that he does not think that micromanaging staff is the right thing for the Assembly to do. Commented
