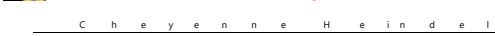

SUMMARY STATEMENT:

A Memorandum of Agreement has been developed between the State of Alaska Department of Transportation and Public Facilities (ADOT&PF) and the Matanuska-Susitna Borough regarding the transfer of Stringfield Road.

ADOT&PF planned, designed, and constructed the Trunk Road Reconstruction Project, which included right-of-way acquisition for what is now referred to as Stringfield Road. ADOT&PF currently owns the Stringfield Road right-of-way and wishes to transfer those rights and associated future maintenance responsibilities to the Borough.

The Borough agrees to accept the transfer and will assume

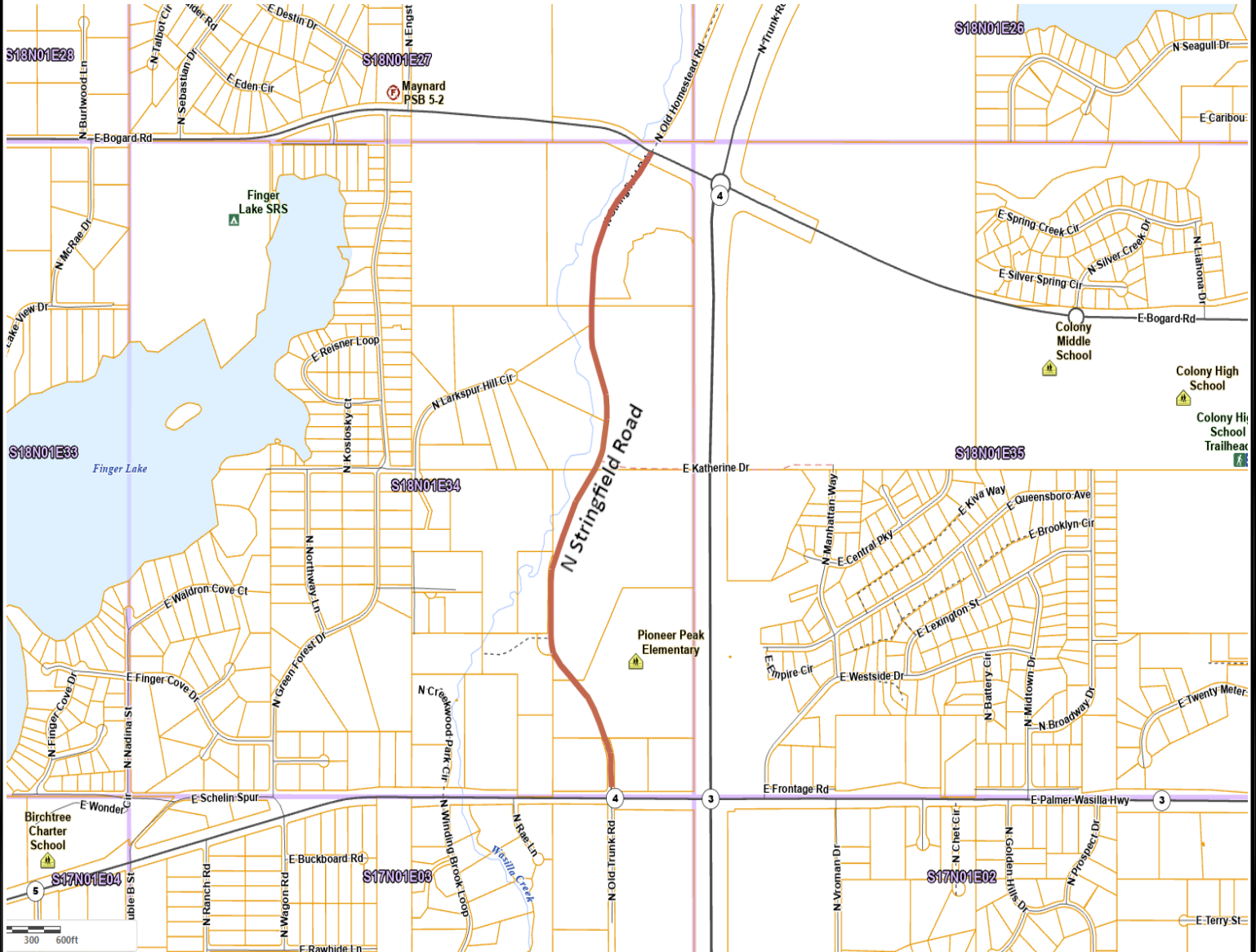
responsibility for maintenance and operations of Stringfield Road, including lighting, local signage, winter maintenance, pavement, gravel, drainage, guardrails, and related improvements at its sole cost and expense.

The Borough's maintenance obligations are subject to annual appropriations by the Matanuska-Susitna Borough Assembly, with Borough officials expected to make good faith efforts to secure funding.

The legislation will authorize the Manager to execute the agreement, once negotiated with ADOT&PF, which will transfer the ownership of Stringfield Road when the conditions in that agreement are met.

RECOMMENDATION OF ADMINISTRATION: Approve the legislation as presented.
