SUMMARY STATEMENT:

This ordinance reappropriates \$125,000 from the Matanuska-Susitna Borough Planning Department's Fiscal Year 2026 Operating Budget (Planning Studies) to support an update to the Port MacKenzie Master Plan. The Planning Studies budget contains funds that are not expected to be fully expended, making them available for reallocation. The Port MacKenzie Master Plan was last updated in 2016 and is intended to serve as a living document that should be revised following significant port development or shifts in economic conditions. Over the past decade, both the regional economy and the potential industrial development landscape have

changed substantially, warranting a comprehensive update. In addition, the Borough has applied for a Denali Commission grant to help fund this effort.
