SUMMARY STATEMENT: Project No. 30047 includes multiple road improvements within the Road Service Area 27 capital program, including West Swan Drive and South Rainbow Street Improvements (Subproject 30047-6600-6712) and Herkimer Drive and Spring Drive Improvements (Subproject 30047-6600-6693).

Subproject 6712 has an available balance of \$555,050.00 of its \$648,405.00 total budget. Subproject 6693 has an available balance of \$577,935.00 of its \$821,083.52 total budget.

The W. Swan Drive and S. Rainbow Street Improvements project is currently in the right-of-way phase. Design is approximately 65% complete, acquisition drawings have been prepared, and negotiations are ongoing. However, funding proposed in the FY2027 budget for Road Service Area 27 is insufficient to support construction in 2027. The construction schedule remains dependent on completion of right-of-way acquisition, utility relocations, and availability of construction funding.

The Herkimer Drive and Spring Drive Improvements project has completed right-of-way acquisition and design, and utility relocation plans have been received. Due to higher than anticipated utility relocation costs, current funding is insufficient to advance the project to construction based on relocation cost estimates, the engineer's estimate of probable construction cost, material testing requirements, and appropriate contingency.

To advance the Herkimer Drive and Spring Drive Improvements project and support a planned 2026 advertisement, additional funding is required to cover construction, utility relocations, inspection and testing, and contingency.

This action reallocates \$80,000.00 within Project No. 30047 from Subproject 6712 to Subproject 6693, increasing the total budget for Subproject 6693 to \$901,083.52.

The remaining balance of \$475,050.00 will remain in Subproject 6712 to support continued right-of-way acquisition and project development. Public Works anticipates submitting future capital requests to fully fund utility relocations and construction once right-of-way acquisition is complete.

The Project Management Division will continue to actively manage the Road Service Area 27 Meadow Lakes capital program to deliver projects as close as possible to their intended scope while addressing cost escalation and project specific challenges.

RECOMMENDATION OF ADMINISTRATION: Approval is respectfully recommended.
