SUMMARY STATEMENT: This resolution is at the request of Assemblymember Nowers.

The resolution authorizes the Planning and Land Use Department to solicit a Request for Proposals (RFP) for a qualified hydrologist to conduct a comprehensive analysis of long term hydrologic conditions affecting areas in and around Irene Lake, Canoe Lake, Kepler Bradley Lakes, Pioneer Meadows, Crimsonview Subdivision, and the greater Palmer area and to amend the scope of work and title of an existing FY26 sub-project account and to utilize previously appropriated funds to solicit a Request for Proposals (RFP) for a

qualified hydrologist.

This effort is in response to a signed petition from 104 residents raising documented concerns dating back to 2003 regarding rising lake levels, property damage, land loss, and potential risks to drinking water quality, including impacts on private and community wells.

The proposed study would provide an independent, science-based evaluation of historic and current hydrologic conditions, including surface and groundwater interactions, lake level trends, contributing hydrologic factors, and potential future risks. The study is also expected to assess impacts to properties and water supplies and identify potential mitigation options. The intent is to develop objective technical information to inform future policy, planning, and capital decisions.

The requested scope amendment reflects a shift from the sub-project's original purpose, air quality outreach and potential PM2.5 non-attainment mitigation to a groundwater-related study. The sub-project scope was previously amended on April 4, 2023, to support public engagement activities. Following additional Assembly discussion and significant public input, it was determined that a groundwater study is an appropriate and responsive use of the funds.

Approval of the accompanying resolution does not commit the Borough to any specific mitigation measures, capital projects, or regulatory actions. It solely authorizes the solicitation of professional services to better understand the issues raised by the community and to support informed decision-making.

While the exact cost of procurement is not yet known, it is anticipated to be in the range of \$30,000 to \$50,000. No new appropriation is requested. The study would be funded using existing FY26 project funds previously approved by the Assembly.
