ATTACHMENT (S) : FERMO QUOTE

SUMMARY STATEMENT: EMS has completed its evaluation of ambulance stretcher systems offered by the two primary manufacturers, Stryker and Ferno. Based on this review, EMS has selected the Ferno Power X-2 as its new standard stretcher platform, replacing the Stryker Power Pro XT, and will also transition to the Ferno Pro F1 mounting system. A portion of the existing stretcher fleet has been in service since 2007 and has reached the point of replacement.

This change will enhance occupant and patient safety by improving stretcher securement and crash performance within the ambulance

patient compartment. The selected mounting system also provides forward compatibility should the Borough pursue powered autoloader systems in the future. In addition, the new stretcher platform includes several design improvements intended to support patient comfort and reduce ergonomic strain on field personnel, including:

Relocation of the portable oxygen cylinder closer to the patient's head.

Surface extenders to better accommodate larger patients

Knee gatch positioning for improved patient comfort.

Integrated LED lighting beneath the stretcher for improved visibility in low-light conditions

The purchase also includes a five-year essential protection and maintenance plan.

This purchase is being made directly from the manufacturer and incorporated Sourcewell pricing, saving the Borough \$266,581.76 off standard pricing.

Funding for this purchase is through a Capital Improvement Project account, Project number 45225-1844 and 45225-1847
