SUMMARY STATEMENT: The compensation for the members of the Board of Equalization is currently set at \$50 per daily session. Other Borough Boards are paid at a higher rate of \$100 per day, and often serve less days in a row than some of the Board of Equalization members. The intent of this proposed code change is to increase their daily compensation so the Borough is able to find knowledgeable members of the community that are willing to serve. Even if the Board of Equalization convenes prior to the legislation taking affect, if passed the new rate of compensation is intended to apply to all board meetings in 2026 and until amended.
